BY USING THE AVImark VETERINARY MANAGEMENT SOFTWARE, YOU ARE AGREEING TO BE BOUND BY THE TERMS OF THIS LICENSE. IF YOU DO NOT AGREE TO THE TERMS OF THIS LICENSE PLEASE RETURN THE UNUSED SOFTWARE TO Henry Schein Veterinary Solutions, LLC (hereafter, HSVS).

#### **LICENSE**

The AVImark system, demonstration, and other software accompanying this License, whether on disk, in read-only memory, or on any other media and related documentation are licensed to you by HSVS, HSVS and/or HSVS's licensor(s) retain title to AVImark and related documentation. This License is only transferable upon the express, written consent of HSVS. You may not sell, donate or otherwise distribute the AVImark media and related documentation to another party without written consent from HSVS.

#### **CONTENT LICENSE**

During the term of this Agreement, Customer grants HSVS a royalty-free, worldwide, non-exclusive license to access, edit, modify, adapt, translate, exhibit, publish, transmit, participate in the transfer of, reproduce, create derivative works from, distribute, perform, display, and otherwise use Content, including through Customer's practice management software, and to generate new information through AVImark functionality or other Subscription Services, solely for access and use by the Customer or affected Clients, and otherwise for the benefit of Customer and Client pursuant to this Agreement.

#### **USE AND DUPLICATION**

This license allows you to use AVImark on a single computer or single-segment local area network. You may make copies of AVImark in machine-readable form for BACKUP PURPOSES ONLY. #### **SUBSCRIPTION SERVICES:**

HSVVS shall implement safeguards and data security protocols designed to prevent the unauthorized disclosure of Individual Information. Customer agrees that HSVVS is permitted to access and use the data maintained on Customer's locally installed Software and any database maintained in connection with the Software (the "Customer Data"). Customer acknowledges the value to veterinary science and the veterinary industry of statistical information on diseases and treatments and of the benefit of assisting HSVVS or third parties who provide useful information to the veterinary industry, veterinarians and pet owners. Customer understands that HSVVS may access, analyze and/or aggregate Customer Data with data and other statistics that it gathers from sales, customer support, website traffic or its other customers (including Individual Information), and may

This License is effective until terminated. You may terminate this License at any time by terminating the use of the software, returning AVImark and related documentation and all copies thereof to HSVS.
