Zoetis Reference Labs

Add-ons to Tests

Operators can add onto tests that have already been submitted to Zoetis. The tests will have to be mapped and configured (using the product attachments and the lab request sheets) to generate lab requests for Zoetis for the add-ons to work.

Add-ons from ZoetisDx

Operators can place an order from Impromed Equine, view the results within ZoetisDx, then add additional tests onto the order. When they do this, updates are sent to Impromed Equine on what was added and allowing the operator to reconcile the additional tests in Impromed Equine so they can still do the charge capture.



All Lab Integrations

Defer Submitting Lab Requests

Operators will be able to choose "Submit Later" when they are invoicing lab items which trigger lab requests. Operators can choose to submit when they continue to add products which trigger the generation of lab requests or when the invoice is concluded. Note: This feature is only available when using the product attachments to trigger lab requests when adding items to the invoice.
