Each Covetrus Online Backup subscriber will receive an e-mail acknowledging the success of the upload.

The data is stored for a period defined by you during installation and can be retrieved by download in the event your clinic suffers a loss of data or determines a copy of previous data is necessary. Maintaining multiple copies of backups at separate locations greatly reduces the risk of data loss to your clinic. Online data storage should be a key element in every disaster recovery plan.

Covetrus Online Backup facilitates transferring your critical business data to secure servers. The data is then duplicated to a second secure site to provide greater protection against natural disasters. While you can use a local backup option of your choosing, we recommend the Covetrus Local Backup Software to get the critical business data locally for Covetrus Online Backup to transfer.

The service is completely customizable, allowing you to select how often and how much data you back up and store each month. The cost of Covetrus Online Backup is based on the accumulated amount of data a subscriber uploads in a monthly period.
