Enhanced Wellness Plans

The original Health Plan feature in AVImark has been greatly enhanced and is now referred to as Wellness Plans. It has been improved for ease of use and increased efficiency.

First thing to note is that upon updating to version 2013.0 all Health Plans or Discount Plans will be removed from System Tables and all plan information will now be stored in the Treatment List.

Wellness Plan Setup

To create a plan you will add a treatment in the Treatment List as you typically would. To add plan entries or edit information on the plan you will follow these steps:

- Open the Change Treatment window on that Wellness Plan and select the new **Plan Entries** tab. For the plans that were transferred from System Tables the Included Services and detailed Plan information will appear in this window.
- Right-click New or Choose to add Included Services for the Plan.
 - Enter a Code or Description to add a service.
 - **Discount** is used to determine the percentage of discount this particular service is to receive. This will default to 100%.
 - In the **Count** field specify the number of times this service is to be performed and covered by the plan.
 - Define a **Min Qty to Perform** to ensure the service is administered the desired number of times.
 - Alternate Codes can be used when the current service is no longer appropriate to administer once the pet reaches a certain age or weight during the plan term. You can right-click New or Choose in the grid window to select alternate services. When there is a primary service and alternate services AVImark will not exceed the count set on the main service during the patients plan term.
- Click **Ok** on the Change Plan Entry window once the desired information is entered.
- At the bottom of the Plan Entries window are information fields that will cover the Plan details.
 - **Calculate Plan Charge** will automatically open the Plan Charges window at the time the patient is added to the plan. From this window you can define Recurring Charges.
 - Define the length of the plan in the **Term Count** fields by specifying a number and selecting the length of Days, Weeks, Months or Years.
 - If applicable you can choose a Client Discount Class in the **Courtesy Class** field which will allow the discounts associated with this client class to be applied.
 - **First Payment** is the upfront payment the client will pay when they purchase the plan.
 - A Service Charge can also be applied to cover fees such as processing fees and other various fees.
 - In the **Courtesy Rate** field specify what percentage discount is to be allowed on all treatments and/or items not specifically covered by the plan, if applicable.
 - Select **Auto-Renew** to have the plan automatically renewed once the end of the term has been reached.
 - Use the **Include Tag Alongs** option to apply the plan discount to any associated entries attached to the included services. Leaving this option unchecked will cause AVImark to charge normal price for tag a longs or apply the Courtesy Rate if one is defined. Note that any associated or linked entries to Included Services will automatically be included in the Plan when the parent treatment is administered.

- Once the Included Services are associated with the Plan AVImark will display the Cost, Total Price and Total Plan Amount.
- Click **OK** to close the Change Treatment window after defining information.

Selling a Plan and Defining Recurring Charges

- From the patients Medical History add the Plan by using F2 New or right-click New and click OK to add the Plan. When a Plan is sold the plan name and expiration date will appear in the Plan field in the Patient area.
- If Calculate Plan Charge was selected the "Wellness Plan Recurring Charges" window will open and from here you can set how the client will pay for the Plan. This Recurring Charges window is designed more for MPS and X-Charge users but can be partly used by clinics that do not have MPS or X-Charge.
 - The full Plan amount will appear in the **Total** field.
 - In the **First Payment** field AVImark will carry over the default payment set on the plan; however, this price can be altered per client.
 - AVImark will then calculate the balance and it will appear in the **Payment Remaining** field.
 - The **Term** should automatically be selected if defined on the plan but that can also be changed here if necessary.

- If the client has a stored credit card click on the **Payment Account** drop-down list to select the credit card. AVImark will automatically charge the clients credit card the term payment amount. Leave this field blank if the client wishes to pay for the plans balance by cash or check over the plans term or if they are paying the full cost of the plan upfront.
- After setting the first payment amount, term and payments left AVImark will display the weekly, monthly or yearly amount to be charged in the **Payment Amount** field.
- In the **Service Charge** you can set a fee for processing or other various fees. This fee will be charged to the clients account based on the term set.
- Click Set Charge Plan to set up the Recurring Charges.
- Should the client wish to pay the full Plan amount click Apply Full Charge.

If MPS is set up and a Payment Account is selected, Credit Card recurring payments will be automatically withdrawn from the clients account for the plan payment date defined by the set term. When this date is reached AVImark will display an entry in Medical History indicating the charge and for credit card payments the amount will be withdrawn from their account and a payment entry will appear in Accounting. For clients who are making term payments via cash or check AVImark will display an entry in Medical History and display a balance for the client, you will have to handle the payment manually.

Altering Recurring Payments

If a recurring payment plan needs altered, currently, you can only modify the Recurring Payments within MPS.

- Right-click in the Client area and click Recurring Payments
- Double-click on the recurring payment entry.
- Modify the payments remaining, amount, and/or date, and click OK.

Viewing the Patients Current Plan Information

Once a patient is added to a plan you can view services that have been performed and those that are yet to be performed.

- From the Patient area select the **Wellness Plans attachment** option or use right-click Wellness Plans.
- In this window AVImark will display all the plans the patient is currently on.
- To view detailed information about a plan, select the Plan and choose **right-click Included Services**. AVImark will display services performed and those yet to be performed. For services that are to be performed a number of times during the plan term AVImark will display the Quantity yet to be performed.

Upgrading and Cancelling Patient Plans

Even though a patient is on a current plan there is the potential they can upgrade to another plan.

- In the Patient area click the Wellness Plans attachment option.
- Click on the plan that needs to be upgraded and choose right-click Upgrade Plan.
- AVImark will display plans that are of greater value than their current plan.

- The codes in common between the current plan and the potential upgraded plan will display in a bolded font.
- Select the Plan to upgrade to and click Done. You will need to confirm you wish to upgrade to the selected Plan and then the Recurring Charges window will appear if that option was selected for that plan. The Total will display the difference between the two plans and a First Payment can be entered if applicable. Choose Set Charge Plan.
- AVImark will cancel the current plan and begin calculating from the plan the client upgraded to.
- The current plan name will now appear in the Plan field in the Patient CID area and the expiration date will also be re-evaluated.

- AVImark will calculate the Usage and Remove the plan from the patients Plan History.

Income by Plan Activity Report

With the enhancement of Wellness Plans derived a new report titled Income by Plan Activity, which is similar to the Income by Treatment report. This report will display production statistics for doctors who provide plan services and it can be printed by Doctor or Consolidated.

- From Work with, Report select the Income by Plan Activity report.
- Income indicates what the price was on the plan for any included service or item. In many cases, this will be zero.
- Usage is the quantity within the time period selected that was used in conjunction with a wellness plan.
- Normal Price is the amount normally charged without a discount.
- Plan Value is the Plan Amount multiplied by the Usage.

Wellness Plan Report

The original report for Health Plans has been renamed to Wellness Plan Report. A new option is also applicable to this report and will provide detailed information on patients that are currently on Plans.

- In Work with, Reports select the Wellness Plan Report.
- Under the Income Options tab check the option of **Detailed Wellness Plan**.
- Now if you Preview or Print the Report the original Wellness Plan Report will print along with an additional report. If previewing you will need to Close the first report and then AVImark will display the Detailed report.
- This Detailed Wellness Plan report will list owners and patients currently on plans along with plan information such as name, plan expiration, services fulfilled and those yet remaining.

Wellness Plan Report Advanced Option

Wellness Plan visit invoices can now be included on the Period Totals report. There is a new Advanced Option that will include those patient visits that only consisted of wellness plan services.

- Select the Tool-Wrench icon to open the Hospital Advanced Options.
- Search for visit and select the new option of Wellness Plan Only Visit Count.
- By setting this option to **True** AVImark will total only those Wellness Plan Invoices and display that number as a separate line under the Total Invoices on the Period Totals Report.

Scriptel ScripTouch Signature Capture Integration

This integration is intended to allow the ability to capture electronic signatures for Microsoft Word documents in AVImark. With this integration, users will also be able to use the device to capture signatures for the AVImark Invoice when taking MPS and X-Charge payments.

Requirements and Limitations

- The STFamily.dll and RegAsm files must be installed in the AVImark directory. This should be automatic with the AVImark 2013.0 update.

- The STFamily.dll must be registered. This can be accomplished using the built-in registration tool. Instructions for registration are listed below.

- Workstations intended to capture signatures for documents will be required to have MS Word installed.

- Open Office will not be supported for this feature.

- Workstations intended to capture signatures will be required to have the Scrip Touch signature capture device installed.


- When a document containing the proper signature merge word is printed from a workstation that does not have MS Word or the signature capture device installed, it will just print the document "as is", neither prompting for the signature, nor printing anything merged for that merge word.

Setup

• Register the STFamily.dll using the built-in AVImark utility. This can be accomplished by selecting Utilities > Utilities and typing in InstallScripTouch and pressing OK. Follow all requested prompts and press Install when in the Scriptel Installation window..



- When completed, press OK to the Registration Completed message.
- Open Advanced Options (wrench icon on AVImark CID) and set the **Enable the Scriptel Signature Capture Device** option to 'True'.
- Add the new merge word where the captured signature is desired on the MS Word document. Displayed below is an example of an ESTIMATE.doc.

AVImark areas allowing the ability to capture signatures include:

- Estimate document - Patient Area

- Check-in documents- Appointment Calendar, Patient Area and Whiteboard

- Surgery consent forms- Medical History
- Boarding agreement- Boarding calendar, Patient Area and Whiteboard
- Release form- Patient Area
- Euthanasia consent form Patient Area or Medical History
- Rabies- using the Drs. Signature- Patient Area or Medical History
- Spay doc- Patient Area or Medical History
- Health Certificate- Patient Area, Medical History and SOAP

A 'read-only' copy of the signed document is saved as a File Attachment to the AVImark Client Area.

Use with MPS and X-Charge

Users will also be able to capture signatures and have them be displayed on the AVImark Invoice with the Scriptel ScripTouch signature capture device.

By setting the Enable the Scriptel Signature Capture Device Advanced Option to "True", you will be prompted for a signature when taking an MPS or X-Charge credit card payment within AVImark. This signature will print on the AVImark Invoice and any subsequent reprints of that invoice.

IDEXX PACS Phase III Improvements

The latest phase of AVImark improvements to the IDEXX PACS integration include:

- The ability to initiate shot requests from the IDEXX PACS system and capture the billing charges in AVImark using the i-Vision Mobile app from IDEXX.
- Improvement to the Additional Shot prompt allowing users the ability to choose to charge for the extra shots or not.
- The ability to assign a default shot count to the Change Treatment window for Unspecified Shot treatments.

-

To be able to take advantage of a truly bi-directional integration, IDEXX PACS allows the user to create a study from IDEXX PACS (that did not originate in AVImark) and still bill correctly within AVImark. This requires IDEXX PACS to display the census list from AVImark as well as display a directory of services (AVImark treatment codes that are associated to IDEXX PACS billing codes) to allow the user to select the client, patient, and Charge that the study should be associated to. This can only be accomplished via the i-Vision workflow.

To accomplish this:

- AVImark must be open
- IDEXX PACS server must be open and running

Within the i-Vision Mobile – The current AVImark patients with a "checked-in" status will be displayed.





• Depending on the species. It will display the areas – you can select for the shot needed.



• Once an area has been selected the following window will appear and the shot will show up under the 'shots requested' area.

****NOTE:** Before the request can be submitted you will be required to 'close' the small window displaying the shots to select.



• Once 'Submit' has been selected you will receive confirmation.



- Refresh IDEXX PACS and capture the requested shots.
- With the shot showing in the i-Vision Mobile



• Once the server has run, the shots will be displayed in AVImark Medical History.

Additional Shot Prompt Change

We have changed the way the user is prompted for additional shot fees by allowing more flexibility for clinics. When additional shots (beyond the shot count originally requested) are found, users will now be presented with the following confirmation message:

"IDEXX-PACS imaging request had more shot(s) taken than requested. Would you like to charge for these additional views?"

Pressing "Yes" will add the miscellaneous shot to Medical History with the additional charge and the images will be imported.

Pressing "No" will not add any additional charges or entries into Medical History. The images will be imported.

Unspecified Shot Treatment Improvement


This addition allows the user to set a default number of shots and create multiple billing codes for 2 view, 3 view, etc... without requiring the user to remember the number of shots to set each time a shot request is made.

You will see a Shot Expectancy field when creating a new Radiography entry and clicking on the 'Unspecified Shot' option.in the Change Treatment > Laboratory > Radiographs window. In the example below, the Shot Expectancy was set to 1:

Hovering over the Unspecified Shot button will display:

"Use this if you want to specify # and type of shots in free-form text at entry."



When creating a Request for the above Unspecified Shot example, the 'DICOM Request Instructions' window in Medical History will default to '1 images' – this can be changed on demand and show appropriately in PACS. In the below example, the count was changed to 3:



AVImark will bill the client correctly for the requested shot count.

****NOTE:** If a user attempts to add a shot count or any shot request default values to the AVImark treatment code represented in Advanced Options as the IDEXX Digital Imaging Miscellaneous Shot Treatment Code, the following warning will be displayed:

"Warning: Do not assign an image request to the IDEXX-PACS Miscellaneous Code."

Intelligent Inventory Phase II Improvements

Ordering items through Henry Schein Animal Health can now be accomplished directly from AVImark. We have added access to this ability from the AVImark Needs List as well as from the AVImark Purchase Order system.

Some new Advanced Options have been added to accommodate this feature. In Advanced Options, type Henry Schein into the Search field. Expand the Henry Schein Animal Health Shopping Cart menu to display the following fields. Information for these fields can be obtained from your Henry Schein Animal Health Account information.

- Account Number
- Password
- Sequence Number
- User Name

Placing an order from the AVImark Needs List

Within the AVImark Needs List you will find a new menu item labeled Henry Schein Animal Health.

This menu contains two options:

- Place Order this will allow the user to open the Needs List to Henry Schein Animal Health Shopping Cart window to make selections for the Shopping Cart.
- о Go To
 - Account Maintenance will display your Butler Schein account details and allow you to make account changes.
 - Order Details will allow you to search by order number to find details of existing orders.
 - Product Search will allow you to view the entire list of products available for order.
 - Promotions will allow you to view all available promotions.
 - Shopping Cart will allow you to view all current Shopping Cart contents.
- When you select the item(s) on the Needs List (by highlighting the item and using the spacebar or using the right-click, Select), it will be placed in the 'Selected' pane in the bottom portion of the window.

- Once all items are selected, you can place your order by selecting Henry Schein Animal Health, then Place Order.
- The Need List to Henry Schein Animal Health Shopping Cart will open displaying the items from the Needs List.





Rounding Penny Total Values

The Royal Canadian Mint has ceased the distribution of pennies and businesses are being encouraged to round cash transactions. With the phasing of the penny for Canadian clinics AVImark has implemented an enhancement to round Cash Payment total values.

AVImark will accomplish this by rounding cash payment totals to the nearest .05. The following rounding rule will be in place: \$0.001 - \$0.024 rounds to \$0.00 and \$0.025 - \$0.049 rounds to \$0.05, \$0.051 - \$0.074 rounds to \$0.05 and \$0.076 - \$0.099 rounds to \$0.10, etc.



If Reuse Empty Accounts was to set to True and Referral Required to Complete Client Information is set to True, users were allowed to add a client without choosing a referral.

1658 - More Stuff Was Not Showing in New Client Window

4459 - More Stuff Panel Allowing Date to Be Selected

If a client more stuff entry has a type of date, the more stuff panel will no longer show the calendar drop down.

Diagnosis:

4887 - Client Server Resolve Changes Window Creating Diagnosis

Creating a new diagnosis with remind as was causing an incorrect resolve changes window to be displayed.

Documents:

4343 - <vacc-due> Merge Word Was Not Working Consistently

4472 - Pref-doctorname Not Working Correctly

In some databases, if there was not a preferred doctor on a client, the Pref-doctorname merge word was printing the first doctor in the list.

Drug Labels:

4437 - Limit Number of Refills Not Working

If an item had the A(action codes but no label saved, when the item was put into medical history, checking limit number of refills and entering 0 was not working.

4432 - Access Violation Printing Drug Label with Sequence Number Set to True

If the Sequence Number advanced option was set to True, printing a drug label from the inventory or treatment list caused the following error: "Access violation at address 0187859F in module 'AVImark 2012.5 develop.exe'. Read of address 00000000"

Equine:

4967 – EQ - Mapping Appointments Printing in Wrong Order

When printing appointments with directions; the appointments were not printing in the order of the appointment time.

Estimates:

4600 - Tax Not Lined Up on Estimate Document

When printing a document with the merge word <estimate>, the tax was not lined up with the rest of the estimate entries.

4685 - Printing Estimate List to Excel Shifting Each Line to the Right

When the estimate list was printed to excel, each row was being shifted to the end of the line of the one above it.

4451 - Declined Estimate Entries Posting to Whiteboard

If an entry on an estimate was declined and the estimate was posted to the whiteboard; the declined entry was being included in the patient activities.

794 - Entry Not Grayed Out After Posting from Estimate

Posting an entry to medical history from a patient estimate was not graying out the entry on the estimate. 752 - Incorrect Price Being Displayed on Estimate

If the default number of days until estimate expires was set to 0 and an item that includes a fee was added to the estimate, the estimate will then show the wrong price.

1849 - Incorrect Price in Medical History

When charging a fee on an item attached to a treatment, posting an estimate with this treatment caused the price to be incorrect. For this to happen the estimate must have had the Default Number of Days Until Estimate Expires set to anything other than 0 and the advanced option Include Surcharge in Estimate set to false. Also the user would have had to change the quantity of the inventory used when the treatment was posted to medical history.

Information Search:

765 - Printing Information Search Results to Excel Both Columns Don't Print

Printing search results that include the phone number and area code to Excel was not including the phone number.

607 - More Stuff Age Reported in Days Instead of Years

When searching for an Age in a more stuff field, the age was being displayed in days instead of years.

605 - Decimal Type Reporting Incorrect Number

When searching for More Stuff with a decimal type the number being reported was not the exact same number that was entered on the medical history entry.

616 - Cannot Search for History More Stuff is blank

Searching for History More Stuff Is Blank was not working.

Inventory List/Purchase Orders:

4525 - Obsolete Items were Showing on Inventory Report

4441 - Txt File did not Contain Item Number when Emailing

When emailing a purchase order, the TXT file did not contain the Item Number.

4433 - Incorrect Resolve Changes Window

If the category and price of a new item was changed, the user was being presented with an incorrect resolve changes window.

4404 - Average Cost Displayed on Associated Entries Tab

The item cost will now be shown on the associated entries tab.

4720 - Species Not Working

In the inventory list, selecting a species to display was not working.

4435 - Prompt to Update Inventory After Updating

When updating from a version below 2012.1 (2010.0 for example) to 2012.1, or above, clinics were being prompted to update inventory unnecessarily.

4768 - Error Adding Variance Reason from New Variance Window

When adding a new Variance Reason from the New Variance Entry window the following error was displayed and the reason was not added: "Assertion failure (E:\Amy\avimark_btr\ubtrEntry.pas, line 230)"

689 - Mixture Item Container Quantity Not Updated

Upon posting entry to Medical History, the Mixture Item container quantity field was not being updated.

684 - Site Doctors Not Appearing in Doctor Drop Down in Change Treatment/Item Window

When logged in as a site clinic, the site doctors will be an option in the Change Treatment/Item window. If logged in as home clinic, the home doctors will be an option in the Change Treatment/Item window.

IVLS:

1453 - IVLS - Status of "Error" in Requisition Management for some Requisitions

If a requisition is created by adding an IVLS treatment directly to Medical History (such as r/c New, F2 New, r/c Choose...etc.), the status displayed the word "Error" in red.

1093 - IVLS: Species Auto Selection was not Recognizing AVImark Equine Species Name of Horse

Medical Condition Record:

4434 - Problem Protocol was not Working Appropriately with Species Specific Entries

Medical History:

2833 - Medical History Price Incorrect When Surcharging by Item Cost/Price

When posting a treatment that is surcharging by item cost/price from an estimate, if the inventory used quantity was changed, the price in history was incorrect.

2050 - Moving Category Not Holding Medical History View Tab Assignment

When moving an inventory category to the treatment list (or a treatment category to the inventory list), the report codes were not being moved with the entries. This caused the entries to no longer show on the

correct medical history view tab. When moving treatment, or inventory, categories SetCodes will have to be run for the type to be changed.

4601 - Incorrect Prompt in Enter Medical History Window

Pressing Enter in an empty Enter Medical History window was causing the following message: "You have not entered an Item, Treatment, or Diagnosis Code. Proceed?" This prompt will only be displayed if something is entered in the description or price fields.

4648 - Message When Logged Out in Note Window

If a Notes window is open when the user is logged out, logging back in and clicking done on the notes window caused the following message: "Add another "%" to this patients medical history?"

4800 - Incorrect Prompt Changing Medical History Quantity

When changing the Medical History quantity of an item with mixtures attached, the following prompt was incorrectly displayed: "The Price needs to be updated. This will overwrite any manually set prices, Continue?"

4583 - Enter Medical History Window Displays Unit of Measure Code

The Enter Medical History window was displaying the Unit of Measure code. The description will now be shown.

833 - <serv-doctorname> merge word printing incorrect doctor on invoice

If the doctor on a medical history entry was changed, the <serv-doctorname> merge word was printing the original doctor, not the newly selected doctor.

Miscellaneous: 4627 - Incorrect Results Path Automatically Added for Abaxis CDS

4476 - Preview Print of Test Results Cutting Off Values

Preview printing the results of some tests, was causing the values to be cut off.

3080 - Travel Sheet Only Printing One Column

If a treatment category with only 1 treatment was included at the bottom of the travel sheet, only the left column was printed on the first page.

4505 - Time Card for Inactive Users not Holding the User Name

A new right click "Include Inactive Users" option has been added to the user area of the time card. This option will allow inactive users to be selected.

4493 - Emailing Attachment Not Allowing Attachment to be Opened

If an attachment was email, the user could not open the attachment until AVImark is closed and reopened.

4363 - Excel Attachments Not Being Printed

When printing the patient chart with attachments checked, excel spreadsheets were not being printed.

4770 - Change Default for "Use Cubex Pricing..."

The Advanced Option "Use Cubex Pricing when Greater than Zero" will now default to be set to False.

4764 - PhotoOrg Not Moving Medical History Photos Correctly

The PhotoOrg utility was not moving medical history photos correctly.

1213 - Work List and Follow-Up List More Stuff Was Not Visible in "New" Windows

4168 - Improper Antech Breed Associated After Antech Breed Selection

4611 - Rebuild Error Working Differently

After completing a rebuild, if an error is found the following message will again be displayed before the errors are shown: "One or more errors shown. Please review and correct the information shown"

4984 - Error Closing Invoice When Changing Computer Date

If the computer date was changed to a prior date and the Auto-Payment advanced option was set to none, closing an invoice caused the following error: "File access error detected. This may indicate a lost network connection. Close AVImark? Error. Record, Client, record number, 34, record state, Modified. Error. File, CLIENT.V2\$. Unable to retrieve lock RecSize: 512, RRN: 33. Error code, 33."

4987 - "Invalid Base64 Character" Error Updating from 183.4

Updating clinics from older versions was causing the following error: "Invalid Base64 Character" when AVImark was opened. If you are currently getting this error, please call our technical support department at 877-838-9273 for help stopping this error.

4996 - Cash Drawer Opening Inappropriately when CC Payment Taken

A serially connected cash drawer was opening inappropriately when a credit card payment was taken.

MPS: 4872 - The MPS Login Window Will Always Open in Front of AVImark

Reminders: 4491 - Medical History Not Being Rebuilt When Applying

When applying reminders, medical history will also be rebuilt.

4551 - Choosing Reminder Not Following Interval on Reminder Template

If a patient specific reminder is creating by choosing the code, if there is a reminder template on the code, the interval will be the same as the reminder template.

4592 - Error if no Reminders in Vaccine History

If there were no reminders in the Vaccine History window, checking Show All Reminders was causing the following error: "List index out of bounds (0)".

4844 - Error Attempting to Open Reminder Template

If REM03 was secured and an unauthorized user was logged in, attempting to open a reminder template without a species caused the following error: "Cannot focus a disabled or invisible window"

Reports: 4630 - Total Tax for Multiple Entries Not Included in Patient Summary

4602 - Referral Report Was not Grouping Business Referrals Together

4579 - Tax on Reports not Matching Invoice

In some cases, the tax on the Account Summary and Period Totals was off by .01. These now match the invoice.

4641 - Printing Time Card Report to Excel Shifting Column Over

Printing the time card report to Excel was causing the date column to shift over one column to the right. 812 - Account Summary Option Not Working Correctly

When the Advanced Option, "Include Inactive Clients in Account Summary Totals", was set to TRUE, the amounts were being included in the totals, but no longer listing the "Change in A/R" for Inactive Clients.

1146 - dd/mm/yy Date Format for Canada

When using the dd/mm/yy and English (Canada) date format, the dates in work with reports were not defaulting correctly.

4888 - Drug Label Not Printing on Controlled Substance Report

The drug labels were no longer printing on the controlled substance report.

4999 - Period Totals Tax ON Amount Not Including Returns

The Period Totals tax ON amount was not including returns.

SQL:

2938 - SQL - Information Search for Tests Caused Error

When using the information search to look for test information, the following error was being displayed: "The multi-part identifier "Test. Recno" could not be bound."

852 - SOAP More Stuff Not Importing to SQL

Upon creating "Phrase" type morestuff for each of the areas of the Medical Condion Record and importing to SQL; the information from the pre-import data was not being included in the new SQL data.

4271 - SQL - Unable to Add Breed in System Tables-SQL Data

Attempting to add a breed in SQL would cause the following error: "Error. Record, Breed Entry, record number, 5620, record state, Loaded. Record is deleted. Record, 5620 not found."

4047 - SQL - Searching for Account-History-Treatment Code Caused Error

When searching for the Account-History-Treatment Code the following error was being displayed: "Parameter 'Client Active000' not found."

4620 - SQL - Purchase Order Name is Blank after Updating

Upon updating, previously existing purchase orders no longer showed the "Name" in the Order...Choose window.

4692 - SQL: Locking Prompt When Running ChgAcctDate

In SQL, when attempting to run ChgAcctDate clinics were presented with the following message, even when not using account locking: "This utility is unable to run due to the Account/History Locking feature. Account Locking was set by a System Administrator. Contact AVImark Technical Support at 877-838-9273 option 1 option 1 if you need assistance."

862 - SQL - Error Attempting to Remove Blank Line from Table Type More Stuff Field

Attempting to remove a blank line from a table type more stuff caused the following error in SQL: "Error. Record, More Stuff Entry, record number, 1442, record state, Loaded. Record is deleted. Record, 1442 not found."

4976 – SQL - Clinic Receiving Error Attempting to Open the Reminder Text for First Reminders

Attempting to open the first reminder text in hospital setup caused the following error: "Error. Record, WP, record number, 7172061, record state, Loaded. Record is deleted. Record, 7172061 not found" **Treatment List:**

4543 - Error Adding Comments to New Treatment Before Saving

Adding comments to a new treatment before saving the treatment caused the following error: "Error. Record, Treatment, record number, -1, record state, New. Associated record, WP, has an invalid record number."

Users and Security:

4621 - APT09 Not Working Correctly

If APT09 was secured, an unauthorized user could still create a block off exception, which in turn removes the block off.

Whiteboard:

4552 - Incorrect Resolve Changes Window

When a treatment group was added to the schedule tab of the whiteboard, and posted, a resolve changes window was being incorrectly displayed.

4718 - Discounted Group Price Not Working From Whiteboard

When posting an expanded group from the whiteboard to medical history, the discounted price was not being charged.

844 - Whiteboard Column Heading For Whiteboard Category Was Not Correct

788 - Using Military Time with Dosage Schedule in Whiteboard

When using Military Time Format, the dosage schedule was incorrect in the whiteboard.

2013.0.5.0 Fixes List

2669 - Error Message Running Info Search in SQL Running some searches in SQL was causing errors and the results were not displayed. This search is now working correctly in 2013.0.4.0

5105 - Cannot Add Date to More Stuff

More stuff with a type of date, could not be edited from the work list, follow up list, or whiteboard.

2013.0.6.0 Fixes List

5104 - Notes Not Importing on Sidekick

Some notes were not importing from the sidekick to the server.

5145 - Abaxis VS2 - Results Field Also Displaying Low Range Value

The Low Range values were showing in the results field, along with the results.

5170 - Needs List Suggestions with Similar Names Combined

Items with similar descriptions were being combined together into one item when moving from the Needs List to the HSAH Shopping Cart.

5153 - Apply From Template Causes Incorrect Reminders to Appear

Applying a reminder from the template was causing issues with random reminders appearing on patient's reminder tabs.

5173 - Phone Menu Options Incorrect in Help About AVImark

The phone menu options in help about AVImark have been updated.

2013.0.7.0 Fixes List

5249 - Not a Valid Date and Time Error Entering Dates with Slashes

Users were getting "05/01/13' is not a valid date and time", when entering dates with slashes instead of dashes.

5244 - Included Services Not Working Correctly After Updating

If a patient was on a health plan before updating to 2013, the included services used were being reset. This was allowing customers to get a discount on services that had already been given.

5098 - MPS - Recurring Payments Reporting Incorrectly

Some clinics reported an issue when running Recurring Payments. The issue was showing up because either the payment was on the Failed Transaction report when the payment actually processed thru Element OR it is putting the payment on the Successful Transaction report when the payment did NOT process thru Element.

5151 - "Not a Valid Date and Time" Error

Some clinics were randomly getting the following error: "Not a Valid Date and Time". This also caused issues with the IVLS.

2013.0.8.0 Fixes List

5268 - Included Services Not Working Correctly if Updating to 2013.0.x then 2013.0.7

If a clinic had updated to an earlier version of 2013.0 then to 2013.0.7.0; an included service, already given to the patient from a health plan, was not being charged for.

5262 - Discount/Amount not Applying Correctly

If a plan had a courtesy rate, after fulfilling a count for an included service, the discount was being doubled. This only failed when using courtesy rate.
