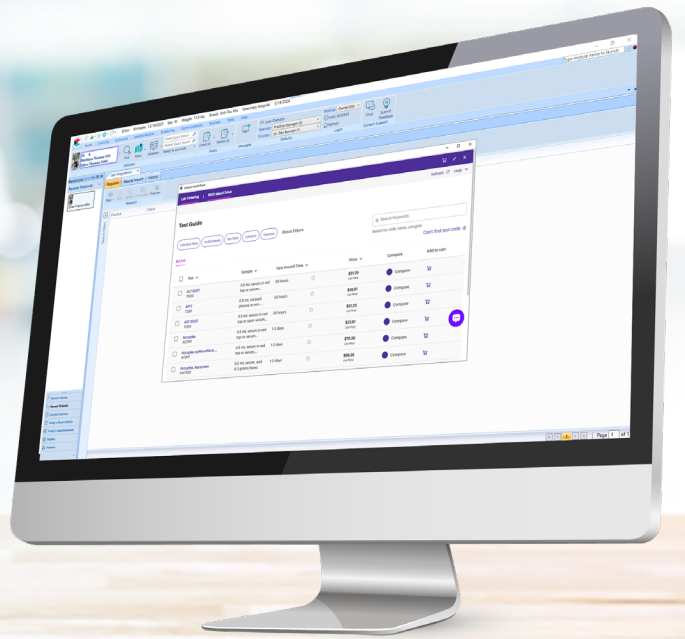


Impromed Equine version 24.11.0 Release Notes



WHAT'S NEW

Antech[®]

- Antech released a new bi-directional integration available to all users where the order is immediately placed and visible to Antech labs. They have also provided an embedded portal for ordering and viewing lab results.

Additional Diagnostic Partners

- Covetrus[®] has provided our users the ability to work with even more lab providers. With the release of 24.10.0 or higher, Impromed[®] Equine will provide a full bi-directional integration with:

WHAT'S NEW

Controlled Substance Log Updates

- The user interface was updated when determining the criteria on the Controlled Substance Log Export report. Review both tabs before running this latest version.
- A new ASAP 2024 v4.2B - CA format was added to adhere to the latest state requirements for California.
- A new ASAP 2024 v4.2 – Generic format was added to adhere to the ASAP standards. Any details entered that your state may require will be included by default. Applicable states may include: Connecticut, Illinois, Maine, Maryland, Massachusetts, Montana, Nevada, New York, Ohio, Oregon, Rhode Island, Tennessee, Texas, Virginia, and Washington.
- Old and outdated formats have been removed.
- Added a generic format to adhere to the following formats: 4.1, 4.2A, 4.2B, and 5.0.
- A new ASAP 2024 v5.0 - NE format was added to adhere to the latest state requirements for Nebraska.
- In the 5.0 formats:
 - ◇ Added the ability to handle using microchip as the ID option for submissions.
 - ◇ Added the ability to handle new client genders supported.

Covetrus Comms

- Rebranded all references of Rapport to Covetrus Comms.
- Sending on-demand text messages through Covetrus Comms now allows for single image file attachments to be included.
- Covetrus Comms users can now send emails directly from Impromed Equine using Covetrus Comms and have them retained in the Communication History module along with Covetrus Comms History.
NOTE: *Single file attachments can be included so there are some limitations on where Covetrus Comms emails can be sent from.*
 - ◇ Impromed Equine will disable sending emails via Covetrus Comms when printing the medical records and choose to include attachments (and link attachments are included) or the Invoice conclusion process (which automatically includes multiple attachments).

WHAT'S NEW

Email

- Documents are now included in the zip file created when users choose to “Email All” while previewing the invoice or will be printed when “Print All” is chosen.

Lab Integrations

- The Lab Integrations module now has an upgraded importing process to provide a smoother user experience. With a new filter, users can view requests for specific labs/machines.
- The View Deleted and Imported lab buttons were removed so we could provide a cleaner workflow.
- On the History tab, users can easily restore a result from one patient to another patient’s record.
- We upgraded and improved many of the previous setup screens to make them easier to use.
- When importing results, users will no longer be prompted for the linking of lab fields to match what is provided from the lab result, because we have automated it for a faster importing process.
- Lab results will include a new status on the Lab Requests tab labeled “Partially Imported” for results which are partially completed. Once the last tests are received, the status is updated to “Imported”.
- Lab requests will now include a new status on the Lab Requests tab labeled, “Lab Cancelled”, for requests the lab cancels.
- A new status for “In Progress” will appear for certain providers when we can collect statuses on the progress of processing the request.

Medical Records

- After choosing to “Enable LabResults Selection” for Notes in Global Medical Record Settings, users can add Note objects to a patient’s record and select a lab result to associate with the note.
 - ◊ A new view was created which can be applied to each desktop labeled “Lab View”. This view indents the note under the lab result and cannot be combined with any other views.
- Users can right-click on imported lab results and see all revisions made to the record (or each update as it was imported).

WHAT'S NEW

Prescriptions

- Improvements were made to the Prescription module to make loading the module faster and increased speed when viewing patients with a lengthy prescription history.

Scheduler

- Apply Block Times was updated for the selection to allow multiple or group selections when choosing who the block is applied to.

Miscellaneous Additions

Recommended / Declined / Deferred Icon Updates

- With this release, new icons were added to the Dashboard for the Recommended, Declined, or Deferred product lists to reflect changes to the invoice lists.

General Updates

- Improved how Improved Equine collects and imports AXIS-Q results.
- Updated the built-in browser to have the latest security updates and enhancements.
- Added the option to deal with the Birthdate and Official Birthdate fields. *Configuration would be required to change the existing behavior.*

USER REQUESTS

- Improved the button locations within the conclude screen. Pendo request 310969
- Clinic Rechecks now has the ability to display the Cell Phone field. Pendo request 148683
- Vaccine records can be deleted if the entry was added by mistake. **Note:** If users are updating them during the invoice process and remove the item before concluding the invoice, the entry will still be removed. Pendo request 296968
 - ◇ The Database Audit Log will not include vaccine history records that have been deleted.
- Updated how Impromed Equine handles the vaccine records when users configure the attachments to happen at different times for the same vaccine. Impromed Equine will now merge the records in these instances automatically to see one record.
- Improved all Enhanced Reports exported to the .csv format to have column headers to clearly define the data so they can be compared to the .pdf version easier.
- Added a new Enhanced Report for all lab partners so users can see what Impromed Equine products are mapped to the Lab Provider tests. New Category: Setup. New Report: Products Linked To Lab Tests. Pendo request 352480
- Removed the cut option from Scheduler so appointments do not get lost. Pendo request 183488
- Added the ability to prompt the user for specimen details when submitting lab requests for certain partners so it is included automatically on the order form.
